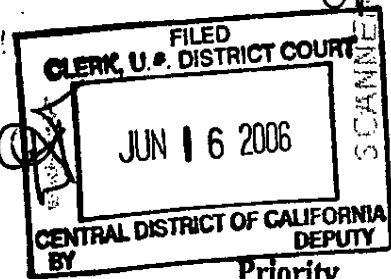

2006 through July 2, 2006.

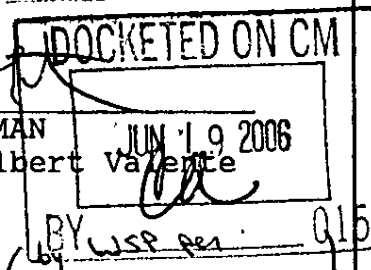


